- I) Pledge of Allegiance
- II) Roll Call: Roger Chaffins, president & citizen member; Bryan Cavender, vice president & councilman; Don Binkley, commissioner; Bill Crase, surveyor; Phil Woolery, extension educator; Byron Walters, trustee; Betty Dotlich, Jeff Fosler, & Denise Thomas, citizen members; Mary Jane Bendt, city representative; Martin Bedrock; commission counsel; Terry Stephenson, administrator/building commissioner and Pamla Starkey, clerk/secretary. There were (9) nine visitors present.
- III) Approval of the minutes of the January 20, 2016
 - ◆ Mr. Cavender made a motion to approve minutes as written, seconded by Mrs. Dotlich. Motion carried. (9-0)
- IV) New and Old Business
 - ◆ Public Nuisance Ordinance
 - Mrs. Dotlich explained what the tech committee has done with the ordinance.
